What is EMS?

Emergency Medical Services is a group of caring friends and neighbors trained in the field of emergency medicine.

EMS includes Medical Directors, ER Nurses, Dispatchers, and field providers. Your local EMS is provided by the Mountain Top Fire Company with two locations. We have the Sandy Ridge Station and a satellite station in Osceola Mills. We own and operate two State Licensed Basic Life Support Ambulances.

The Mountain Top Fire Company has a combination of Paid and Volunteer Emergency Medical Technicians and Emergency Medical Responders on call 24 hours a day.

We have been providing EMS to the Sandy Ridge - Osceola Mills area for over 60 years.

During each year, the Mountain Top EMS transports approximately 400 sick and injured patients.

When should you call for an ambulance?

Deciding to call an ambulance is an important decision. Ask yourself these three questions:

- 1. Is the patient's condition life threatening?
- 2. Could the patient's condition worsen on the way to the ER?
- 3. Would traffic or distance cause any delay in getting to the ER?

If the answer is yes to any of these three questions, then do not hesitate to dial 911. You may reach the hospital faster by driving yourself, but life saving treatment is delayed and in an emergency every second counts.

Because accidents do happen, you must be prepared if you find yourself with an emergency.

To help offset operating costs, we do third party billing.

This is the direct billing of the insurance company.

Most people believe their insurance covers 100% of all costs of an emergency.

The fact is only a small group pay the total bill.

If you do not have a membership you are responsible for the balance of the bill.

An emergency bill can easily run \$2,000.00 with most Companies paying, at most, 80%.

This now leaves you with a great out of the pocket expense. By purchasing a membership, you will not be responsible for any expense not covered by your insurance.
